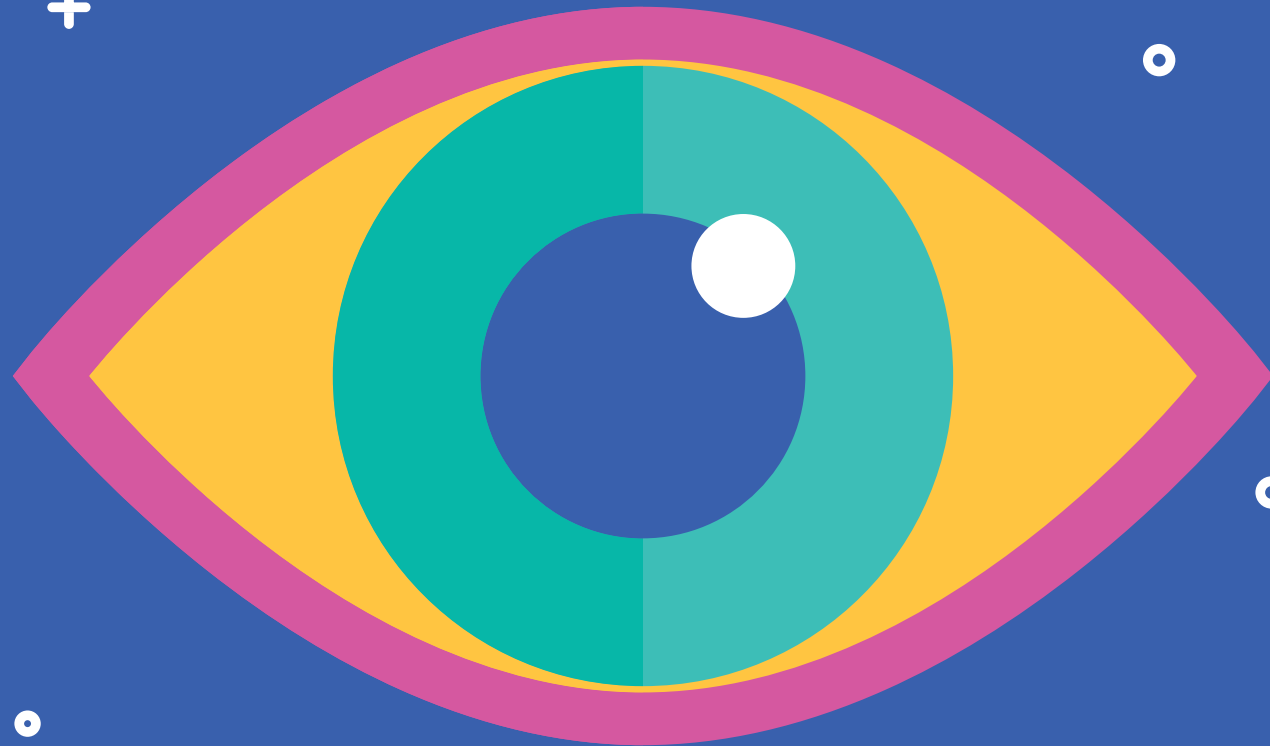
MESSAGE FROM THE BOARD OF TRUSTEES

Chairman of the Board

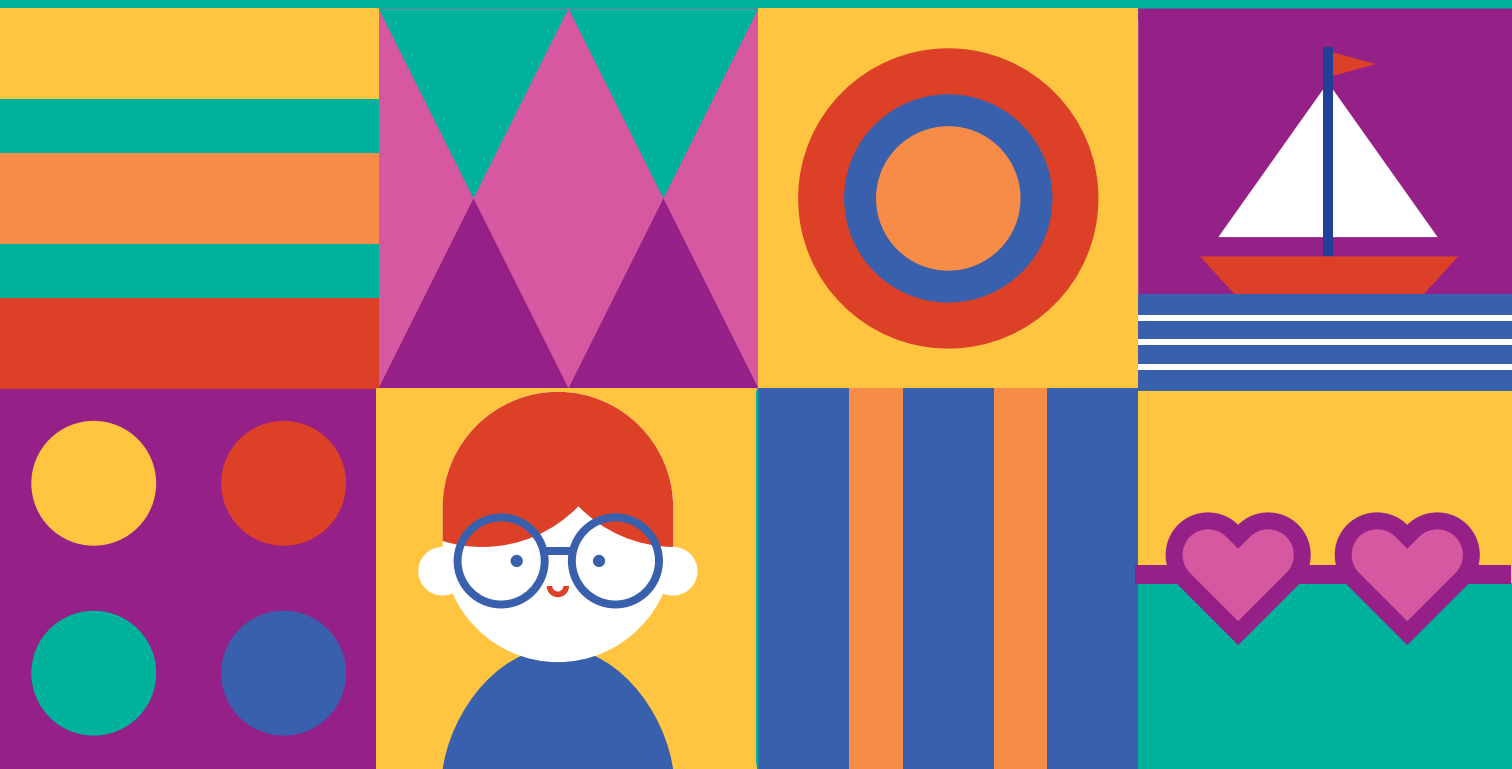
Hisham Ezz Al-Arab is the former Chairman and Managing Director of the Commercial International Bank (Egypt) (CIB). Mr. Ezz Al-Arab has an extensive experience in global banking that spans over 40 years. He has held senior positions at JP Morgan, Merrill Lynch and Deutsche Bank in the United Kingdom and the United States.

His passion to give back to society culminated in the establishment of CIB Foundation. Upon its establishment in 2010, Mr. Ezz Al-Arab assumed the position of Chairman of the Board of Trustees. Since then CIB Foundation became a leading Egyptian voice for universal access to quality healthcare extended to underprivileged children. Having secured CIB shareholders' blessing to commit 1.5% of CIB's annual profits to finance the foundation's activities, Mr. Ezz Al-Arab and CIB Foundation Board of Trustees took Egyptian philanthropy to a whole new level.

Mr. Ezz Al-Arab assumed the role of Chairman of the Federation of Egyptian Banks for two consecutive terms (2013 – 2019); in addition, Mr. Ezz Al-Arab was the co-chair of the Institute of International Finance's Emerging Markets Advisory Council, a non-executive director of the board of Fairfax Africa Holdings, and a Director of MasterCard Middle East & Africa Regional Advisory Board.

Mr. Ezz Al-Arab is currently a non-executive director of the board of Ripplewood Advisors MENA Holdings Limited. Following his retirement, Mr. Ezz Al-Arab established HE advisory, and currently he is the Managing Partner.

Under Mr. Ezz Al-Arab's leadership, CIB has received numerous prestigious international accolades, a testament to the Bank's excellence in management and outstanding performance over the years. Among other awards, CIB received "Best Bank in Egypt" in 2020 by both Euromoney and Global Finance, "Best Regional Bank in North Africa" in 2020 by African Banker, and "Best Treasury & Cash Management Providers in Egypt" in 2020 by Global Finance; in addition, CIB was awarded "Middle East's Best Bank for Corporate Responsibility" in 2019 by Euromoney. In 2019, CIB became the first Arab and African company to be included to 2019 Bloomberg Gender Equality Index (GEI) based on 2018 reports and figures which reinforces CIB corporate social responsibility. Mr. Ezz Al-Arab was rewarded "CEO of the Year" by Global Investor in 2019.

Dr. Nadia Makram Ebeid is presently the Executive Director of the Centre for Environment and Development for the Arab Region and Europe (CEDARE), an international diplomatic position she assumed in January 2004.

Dr. Makram Ebeid was Egypt’s first Minister of the Environment and the first female minister to hold this position in the Arab World. Some of her most notable achievements were raising environmental awareness through mainstreaming environmental considerations into Egypt’s national development policies as well as declaring the River Nile free from polluted industrial wastewater discharge. In addition to being a former member of CIB’s Board of Directors, Dr. Makram Ebeid is also the chairperson and board member of various prestigious institutions, and the holder of more than fifty international and national awards.

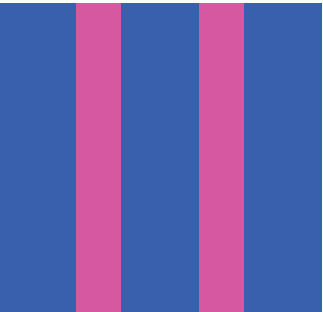
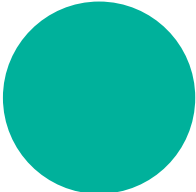

Ms. Maha El-Shahed - the Secretary to the Board of Directors of CIB, and the Office Manager to the Chairman and Managing Director of CIB.

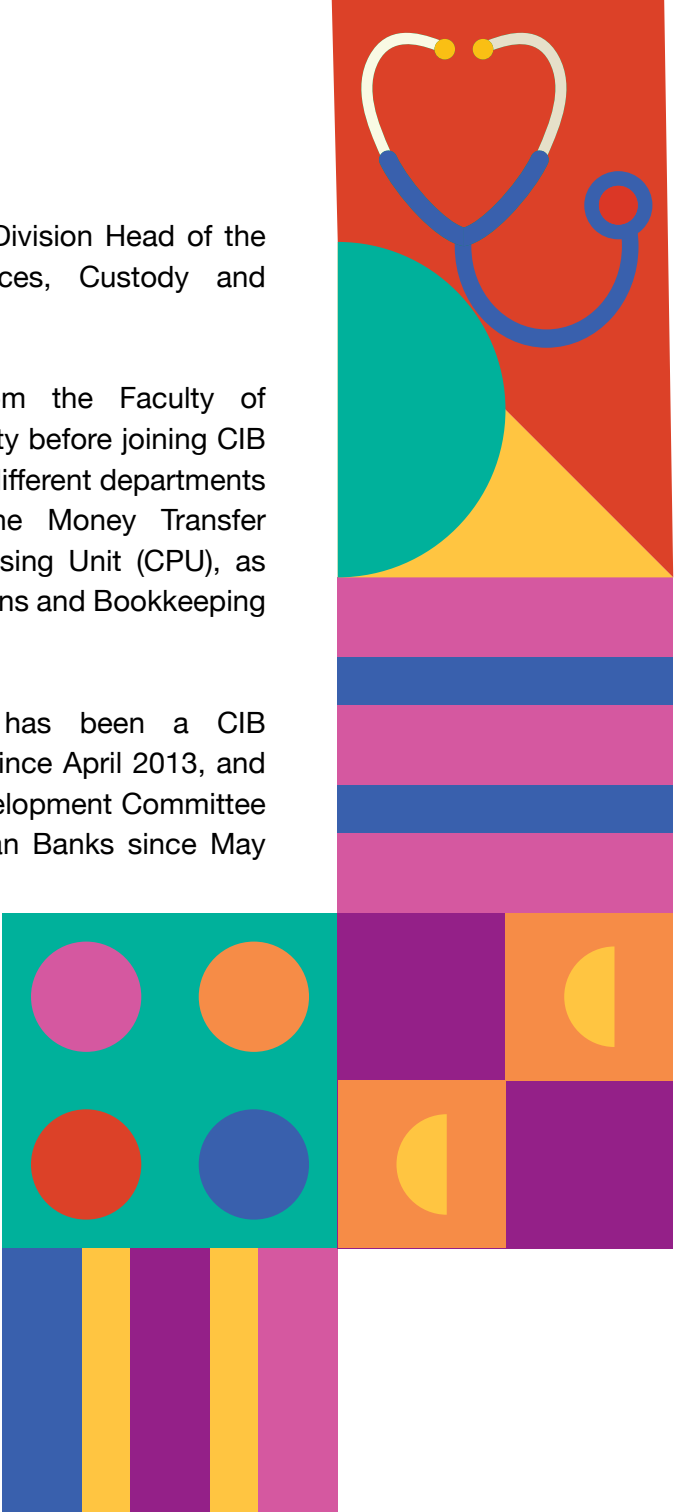
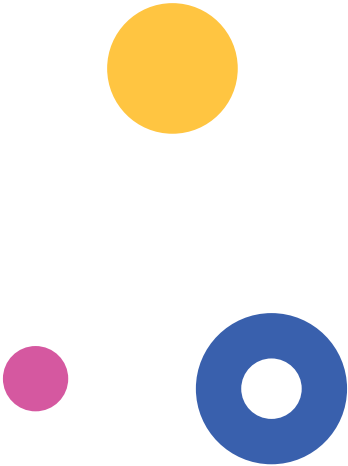

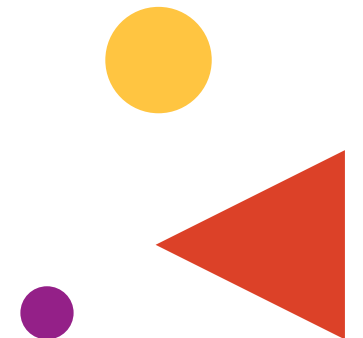


BUDGET & FINANCING



CIB Foundation is supported by the 1.5% of CIB's annual net profit of 2019 from the generous CIB shareholders and the donations made to its fundraising account. 100% of the proceeds are channeled towards community projects with the aim of improving child healthcare services.

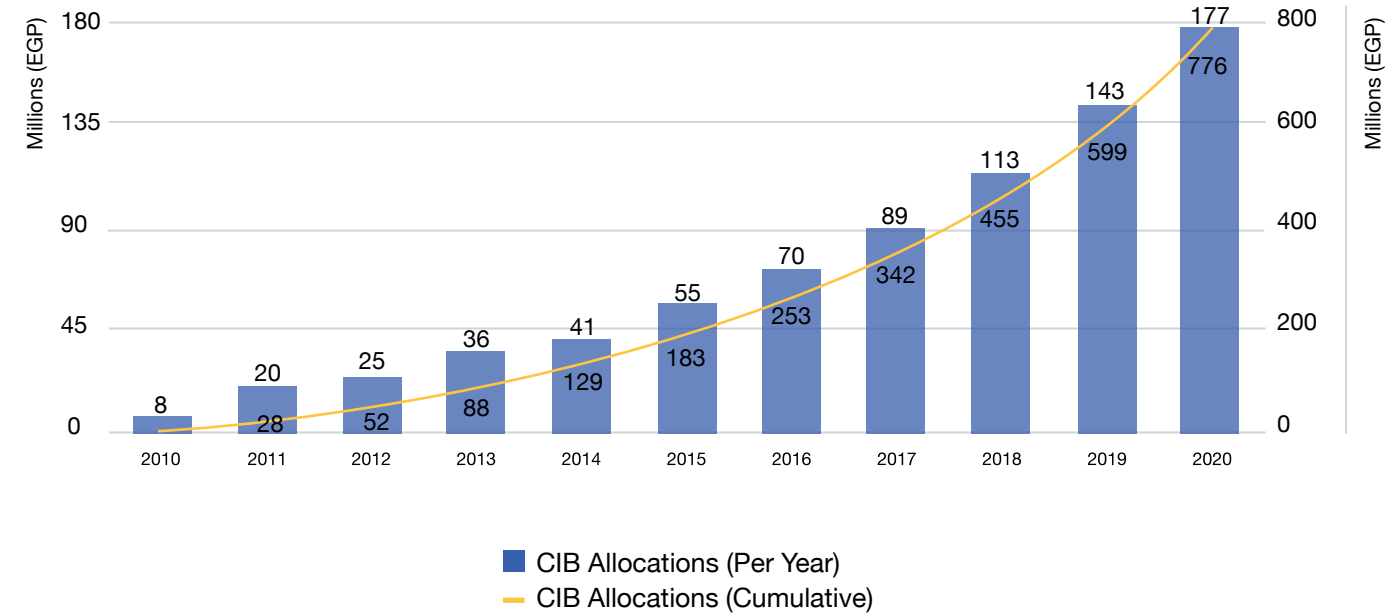

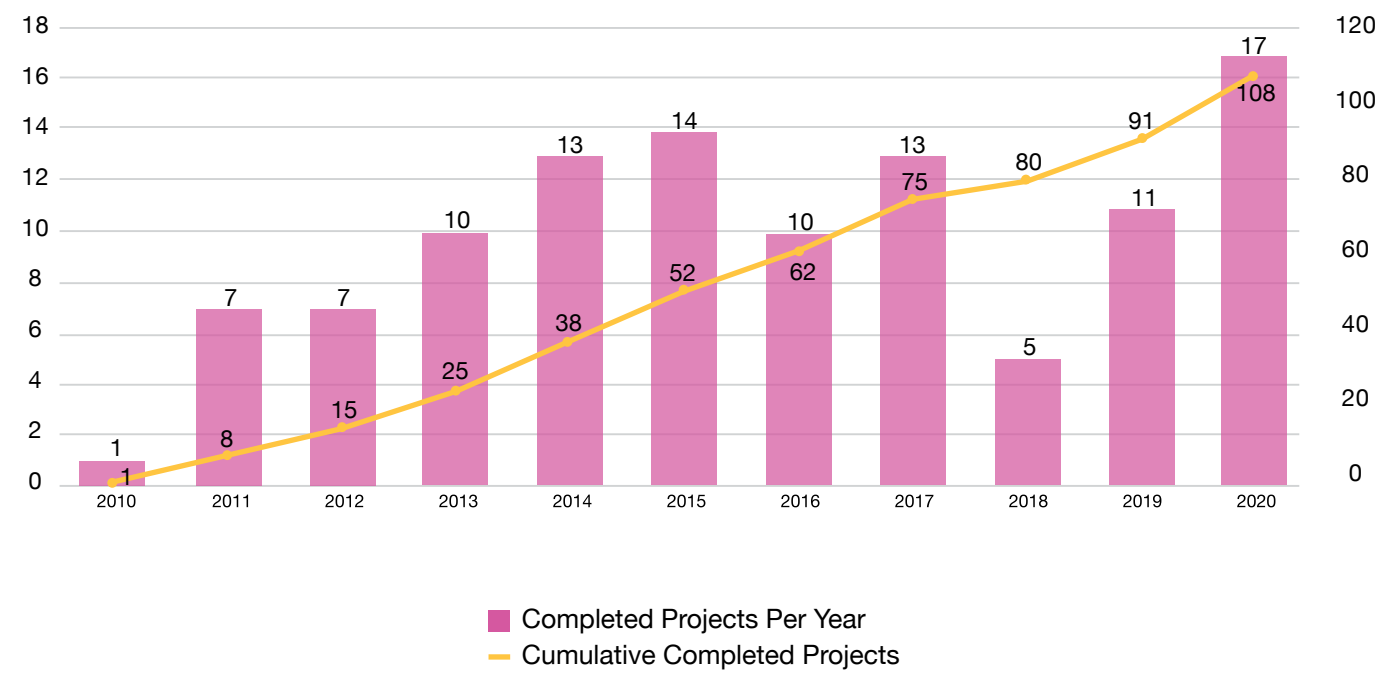

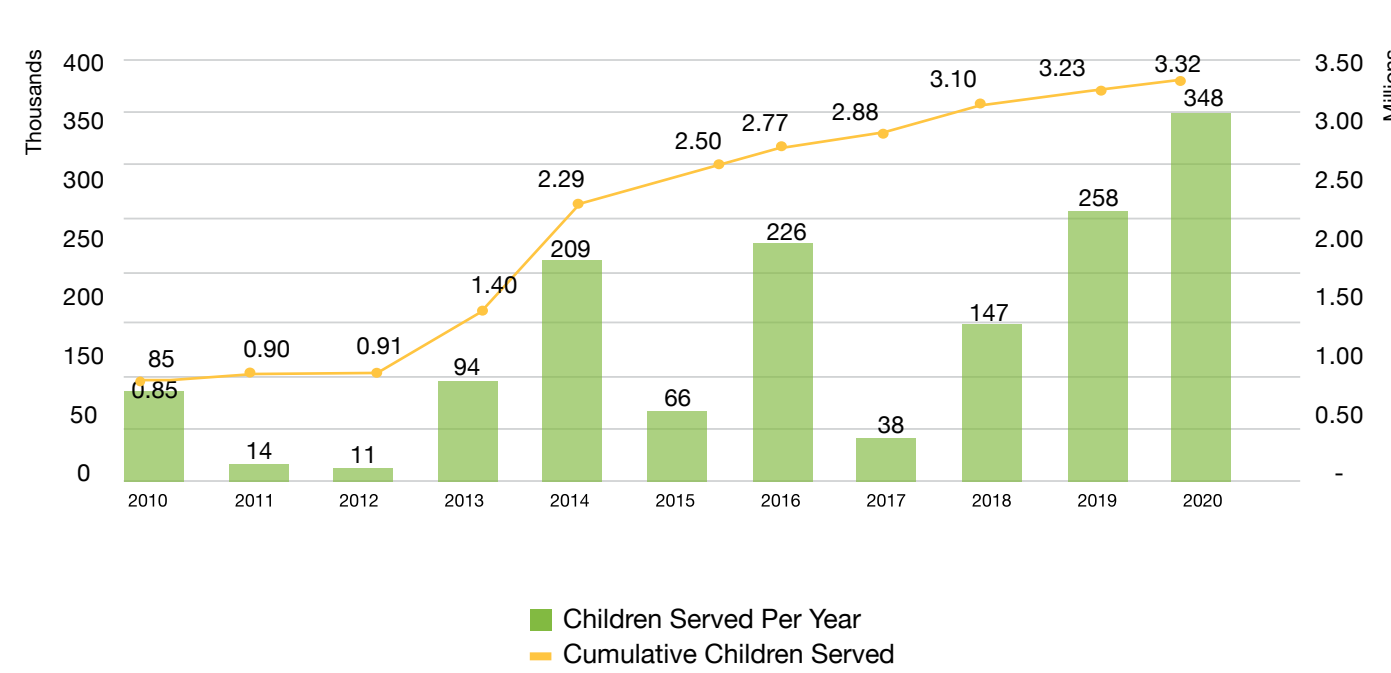
CIB Donations to CIB Foundation since 2010



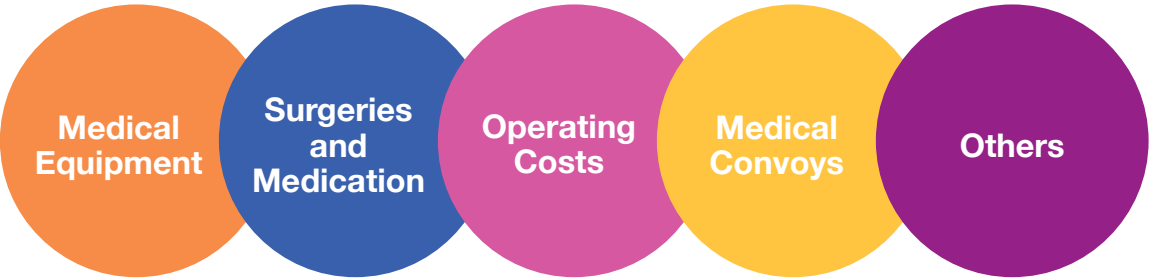
Number of Projects Completed 2010



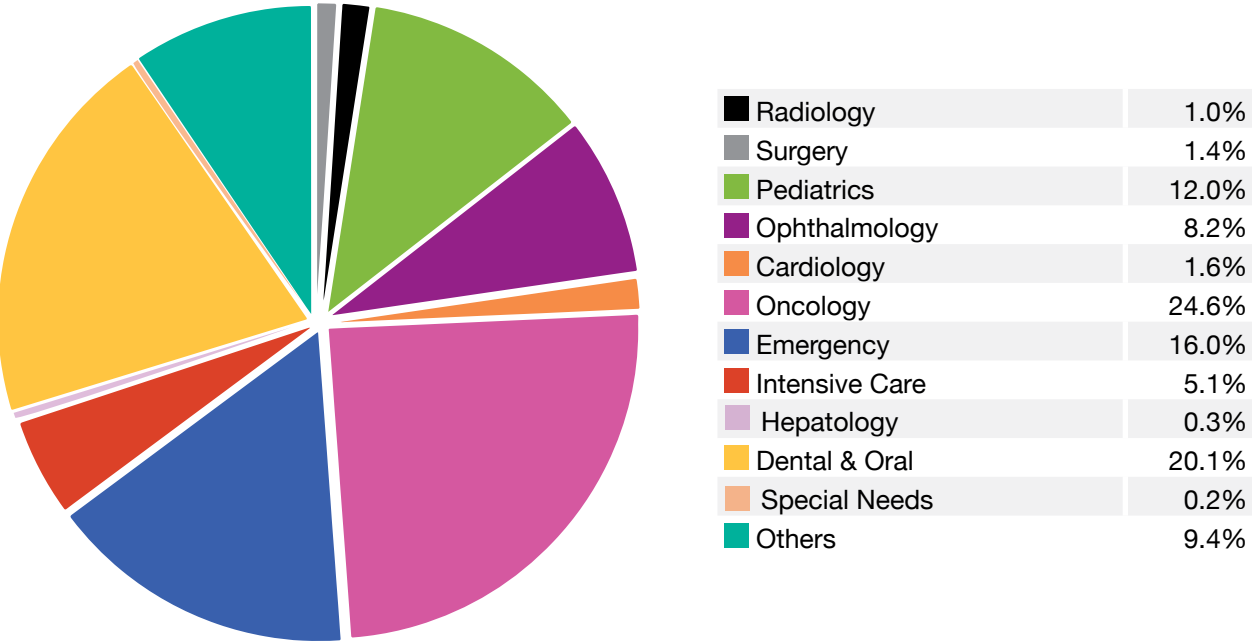
Number of Children Benefited from CIB Foundation Projects since 2010

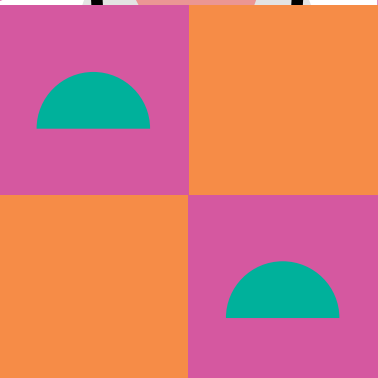

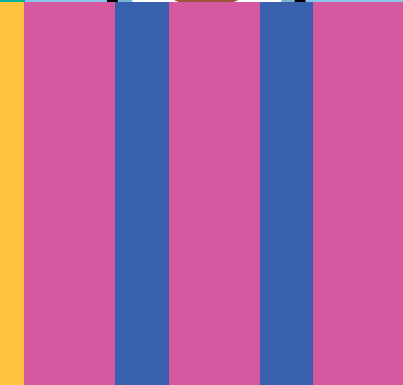

1 FIGHTERS OF 57357

Automated Digital Pathology Lab

Maintaining its longstanding partnership with Children's Cancer Hospital 57357, CIB Foundation allocated an EGP 30 million to establish a Digital Pathology Lab. The digital pathology lab uses a computer-based technology to generate information from digitized specimen slides. Digital specimens are converted from conventional specimen glass slides into digital form which can be electronically-shared and analyzed using computer software. This digital Technology will increase the efficiency of the diagnosis by showing results in a short time (2 days vs 5 hours) and reduce human error. The automated lab is expected to benefit approximately 7 thousands children annually.

390 Infusion Pumps and 216 Syringe Pumps

Building on its longstanding partnership with the Children's Cancer Hospital 57357, the Foundation allocated EGP 20 million in 2019, which enabled the hospital to acquire an integrated system that connects, manages and monitors infusion and syringe pumps during chemotherapy sessions. This is crucial to the hospital as each patient requires a minimum of two syringe and infusion pumps per session. The Foundation will purchase 390 infusion pumps and 216 syringe pumps, as well as auxiliary equipment. This project is expected to benefit more than 18.5 thousand children annually. The entire project amount has been disbursed in two installments in 2020.

Operating Costs

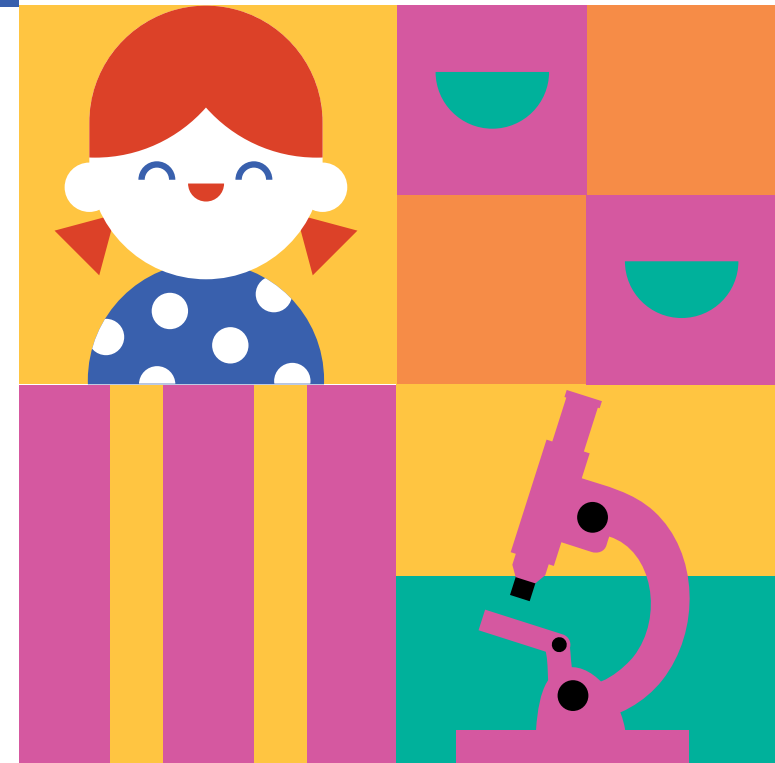
The foundation also allocated EGP 4 million to support the hospital's operations in funding the key activities in Cairo and Tanta branches. The key activities include pathology, blood banks, radiology laboratories, medication, radiotherapy, nuclear medicine, and supplies. The amount was disbursed in full in 2020.

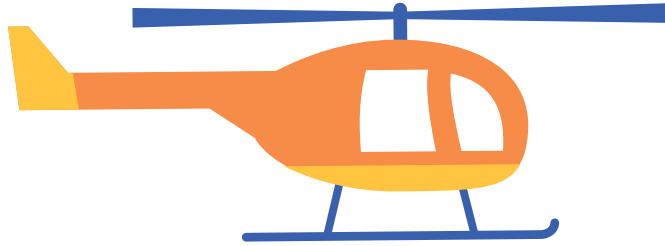

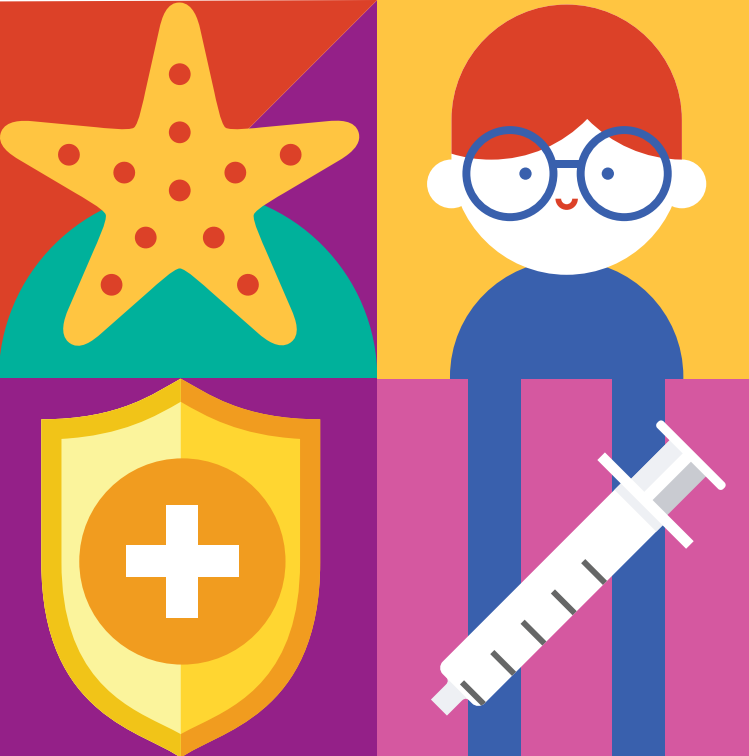

2 A JOURNEY OF HOPE

In collaboration with Nile of Hope Foundation and in the pursuit of establishing a center of excellence in the greater Alexandria region to treat children with congenital defects, CIB Foundation participated in establishing a pediatric radiology department in Nile of Hope hospital by purchasing a Closed MRI Machine (1.5T) with total of USD 1.29 million. The MRI will assist in detecting and inspecting children congenital anomalies syndrome, a structural or functional defects present at birth that may lead to physical or mental disabilities. This project is expected to scan approximately 4.5 thousand children annually. A 60% of the total project amount, which is 12.19 million Egyptian pounds, has been disbursed in 2020



3 A JOURNEY OF HEALING

The Foundation Board allocated EGP 11.77 million in April 2020 to outfit the pediatric department in the Shifaa Al-Orman Hospital in Luxor. The new department allows the children to obtain the required chemotherapy and radiotherapy without the need to travel for long distances since there are very few specialized centers in treating children with cancer in Upper Egypt (in most cases children have to travel to Cairo). The travelling does not only constitute a great health hazard on the patient, but also places a great financial burden on the families. The pediatric department is expected to serve around 900 children annually.

4 OUR DIFFERENCES... OUR STRENGTH

In line with the Foundation's commitment to support children with special needs, CIB Foundation allocated a budget of EGP 5.55 million to establish clinics, rehabilitation centers for cerebral palsy, audio and mental measurement in five rehabilitation centers in Cairo, Giza and Helwan which are managed by The National Foundation for Family and Community Development. This project is expected to serve approximately 1 thousand children annually.

5 THE RIGHT TO LIVE UPRIGHT

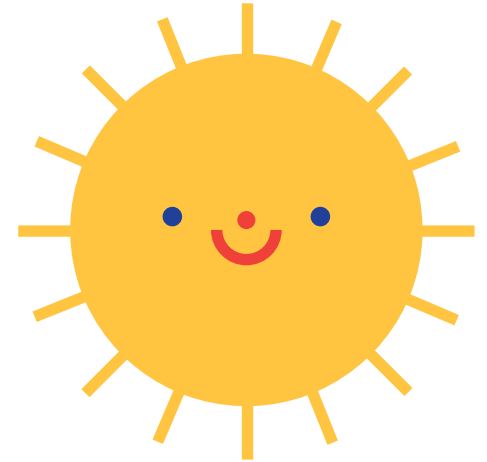
In collaboration with Assuit University Hospital, CIB Foundation will fund establishing a specialized center in treating children with spine problems and deformities.

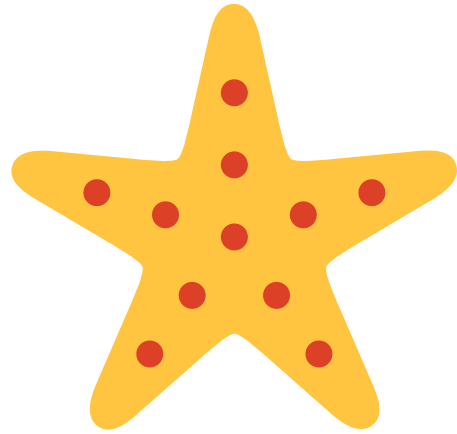
CIB Foundation allocated EGP 4.48 million to purchase surgical equipment to perform the complex and minimally invasive surgical procedures with the highest quality and precision. This unit will enable the hospital to perform 104 surgeries annually.

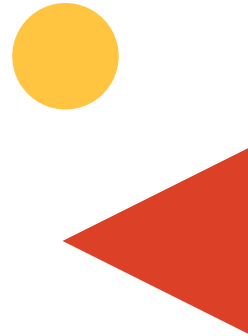
6 TOUCH OF HOPE

Pediatric Cardiac Operating Room

Building on the previous successful collaboration between CIB Foundation and Sporting Students Hospital, the Foundation allocated EGP 3.88 million to establish an advanced pediatric cardiac operating room with the capsule system. Through this operating room, it is expected that the hospital operates on 288 children annually while ensuring the highest levels of sterilization and hygiene. In addition, the capsule operating room will enable the hospital to perform minimally invasive and highly advanced surgeries with the utmost accuracy according to the international standards. This project will contribute to decreasing the numbers of children on the waiting lists for pediatric cardiac surgeries.

Six-Color Flow Cytometry Device

The Foundation granted the Sporting Students' Hospital EGP 3 million to acquire a new six-color flow cytometry device that assists in the accurate diagnosis of leukemia and cancer in the lymph nodes. The device is expected to help diagnose 1.2 thousand children each year. The full project's amount was disbursed in 2020.



7 CHILDREN WITHOUT RISK

Pediatric Intensive Care Unit

The Board approved EGP 3.94 million to outfit a Pediatric Intensive Care Unit in Mabara El Maadi Hospital in collaboration with Lions Club Garden City. The Club financed the construction and finishing works of the unit and the Foundation will outfit the unit with the latest medical equipment.

Egypt suffers from an acute shortage in ICU beds (32% shortage), especially the specialized pediatric ones. The hospital provides service to a large number of patients in the Maadi area and its surroundings, and the purpose of the project is to provide health care to children who suffer from complications.

Providing the necessary equipment for the ICU is expected to serve approximately 600 children each year, and will contribute to decreasing child mortality and treat the diseases that may cause permanent damage and/or disability to children.

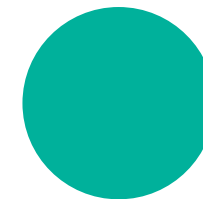
Neonatal Intensive Care Unit

In February 2019, the Board allocated EGP 1.63 million to purchase equipment to operate four new incubators at the Mabara El Maadi Hospital NICU in collaboration with Garden City Cosmopolitan Lions Club. The project enables the hospital to serve around 1,200 newborns annually. CIB Foundation disbursed the final payment after the delivery of all the required equipment and training the medical staff in 2020.

S STRONGER HEARTS... STRONGER FUTURE

Building on the longstanding partnership between Magdi Yacoub Foundation and CIB Foundation, the Board allocated EGP 20 million to fund 100 Pediatric Open Heart Surgeries and to purchase Cath Lab Consumables for 350 children.

According to the data from Aswan Heart Centre, which is a center of excellence, the center performs annually around 4 thousand surgical and cardiac procedures (2.4 thousand children) with quality similar to the quality in Europe and the United States. An amount of 15 million Egyptian pounds has been disbursed from the total project amount in 2020.

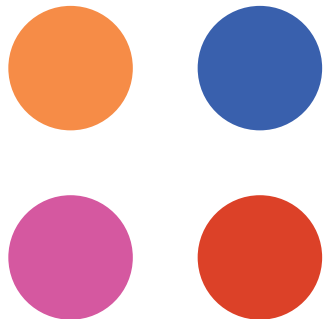
9 GIFT OF LIFE

3rd Round 100 Open-Heart Surgeries

Building on the successful collaboration between CIB Foundation, Rotary Club of Giza Metropolitan and El Kasr El Eini Hospital, CIB Foundation allocated EGP 4.5 million to fund the 3rd round of open-heart surgeries to be performed in El Kasr El Eini Hospital to reduce the number of children on the waiting lists and relief some of the financial burden from the Hospital by sponsoring 100 open heart surgeries.

2nd Round 100 Open-Heart Surgeries

Building on the success of previous collaborations in 2017 and 2018, the Board approved the allocation of EGP 3.7 million in 2018 to support a second round of open-heart surgeries for 100 underprivileged children with congenital heart diseases at the El Kasr El Aini Hospital, under the management of the Rotary Club of Giza Metropolitan. An amount of EGP 1.21 million, which is the remainder of the project, was disbursed in full in 2020.

Rotary District 2451 has noticed during their medical convoys that this congenital/birth defect is evident in Upper Egypt. Since these defects affects the child's appearance and constitute speech difficulties, these defects hinder the children from living a normal life.

11 DIABETIC HEROES

CIB Foundation allocated an EGP 370 thousands for Medicine for All Foundation to sponsor the medications for 250 underprivileged diabetic children for 1 year. The medication will be distributed on children on monthly basis.

12 CHILDREN RIGHT TO SIGHT PROGRAM

CIB Foundation allocated EGP 929 thousands to cover 176 eye surgeries as part of the Children's Right to Sight (CRTS) program in collaboration with the Rotary Club of Kasr El Nile to help eradicate the causes of blindness in children and infants.

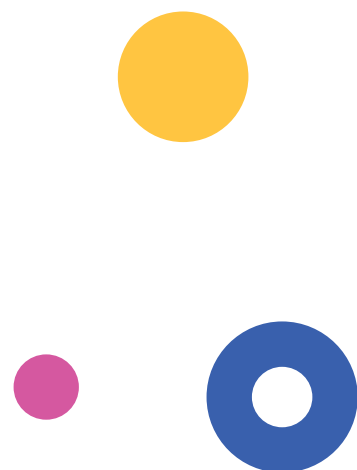

13 THEIR CARE ... OUR RESPONSIBILITY

Building on CIB Foundation longstanding partnership with Yahiya Arafa Children's Charity Foundation, the Board allocated EGP 6 million to fund the annual operating costs of 5 pediatric units in Ain Shams University Hospitals supervised and managed by Yahia Arafa Children's Charity Foundation. In addition, the Board allocated EGP 3 million to retrofit depreciated medical equipment in the 5 units. The 5 units serve around 14.5 thousand children annually. The amount of EGP 6 million allocated to finance annual operating costs, was fully disbursed in 2020.



14 GOING MILES FOR THEIR SMILES

As part of CIB Foundation's mandate to support the children in need, the Board allocated EGP 1.85 million to support the annual operating costs to FACE for Children in Need to cover a part of their medical services and care provided to orphans in Maadi Home center which hosts 50 children.

15 FOR A BETTER CHILDHOOD

Operating Costs

The Board approved a budget of EGP 1.91 million to fund 50% of the annual operating costs of the pediatric and neonatal ICU sections of Benha University hospital which were outfitted through a fund from CIB Foundation. The two units serve about 3.5 thousand of children in Qalyubia region annually. This fund will ensure the project sustainability and maintain the highest level of service provided to the children in the two units.

Outfitting the PICU and NICU

The Foundation granted Benha University Hospital EGP 12.4 million to equip it with 40 incubators and 10 pediatric ICU beds. This planned expansion will enable the hospital to serve approximately 3.5 thousand children each year in Benha and the surrounding areas. The remaining amount of the project EGP 3.32 million, was disbursed in 2020.

16 A WARMER WINTER

In 2020, the Foundation allocated EGP 8 million to fund the 7th collaboration with the Egyptian Clothing Bank to spread warmth among underprivileged children, especially in rural areas across Egypt. The need for winter clothing has been rising for the past few years due to weather fluctuations and low temperatures in the winters.

Through the funding the manufacturing of 50 thousand winter training suits and 50 thousand pair of shoes will be distributed to children in underprivileged areas across the country. The total project amount has been disbursed in 2020

17 PRIVATE SECTOR ALLIANCE Against COVID-19

CIB Foundation allocated EGP 5 million to support the “AmCham Private Sector Alliance Against COVID19” in collaboration with UNICEF Egypt. The fund will be directed to purchasing protective equipment for the medical staff in healthcare units nationwide. The total project amount has been disbursed in 2020.

18 FOR A BETTER LIFE

2020/2021

Building on its longstanding partnership with the MOVE Foundation for Children with Cerebral Palsy, the Board approved EGP 1.39 million to cover 50% of the annual operating costs of the Foundation. The operating costs will enable MOVE Foundation to provide free of charge services to 100 underprivileged children. The annual operating costs cover the staff salaries (physiotherapists, teachers, caretakers... etc.), maintenance work, children transportation, stationary expenses, as well as utility bills.

2019/2020

Building on its longstanding partnership with the MOVE Foundation, the Board allocated EGP 1.2 million to cover the operating costs of the organization for one year to help accommodate more children seeking support from the MOVE Foundation. This fund is expected to cover costs to provide care for 100 children with cerebral palsy. The MOVE Foundation has positively impacted the lives of approximately 250 thousand children with cerebral palsy living in Egypt since its establishment in 2004. The entire amount allocated to the project has been disbursed in 2020.



19 ONE HEART

100 Open-Heart Surgeries

CIB Foundation allocated EGP 10 million to cover 100 pediatric open-heart surgeries to reduce the number of children on the waiting lists and relief some of the financial burdens of the hospital. The hospital, which is managed and operated by Al Joud Foundation, is located in Shubra El Kheima and operates in line with international standards. The hospital offers its services free of charge to the underprivileged children. The first payment, with a total amount of EGP 5 million, was disbursed in 2020.

15 Cardiac Pediatric Intensive Care Units

The Board allocated EGP 33.18 million in 2019 to exclusively sponsor, outfit, and operate 15 cardiac pediatric intensive care units through the purchasing of medical equipment while covering operating costs for six months, as well as sponsoring 40 pediatric open- heart surgeries. The Hospital offer its services free of charge to underprivileged communities. The total fund of the project has been disbursed in 2020

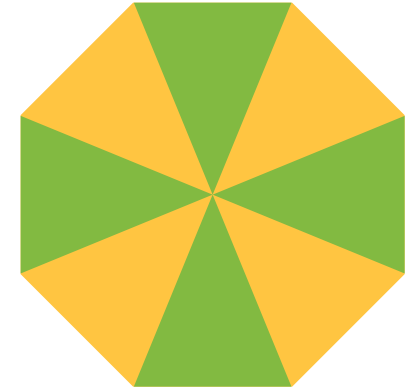
20 CHILDREN WITHOUT VIRUS C PROGRAM

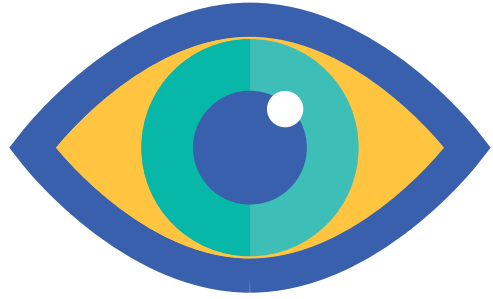
The Foundation has dedicated over EGP 5.1 million to fund the Children Without Hepatitis C program in collaboration with the Egyptian Liver Care Society. The fund covers medications, blood tests, x-ray, medical staff training (doctors and nurses), and awareness sessions for infected children and their families. Since the inception of the program, a total of EGP 2.72 million were disbursed, out of which EGP 1.01 million were disbursed in 2020.

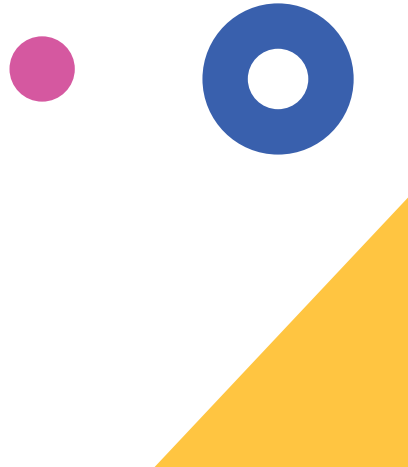
21 FOR A BETTER EYE SIGHT

The board allocated EGP 3.07 million to support the establishing a specialized pediatric eyes center in Memorial Institute for Ophthalmic Research, Giza. The fund will be directed to outfit the outpatient clinics. The project helps in eradicating the causes of blindness in children and infants which is apparent in the Egyptian society. Also, the outpatient clinics in the Pediatric Eyes Center enables the Institute to provide specialized services tailored for children as currently they are diagnosed and treated with adults. The specialized center will be able to extend its services to more children from Giza suburban areas, Upper Egypt, and the Delta region. The expected number to benefit from this project is 12 thousand children per year.

22 6/6 EYE EXAM CONVOY

In April 2019, the Board allocated EGP 21.57 million to fund the deployment of 100 eye exam convoys to provide free eye examinations to 80 thousand students in underprivileged primary schools in the Beni Suef and Minya governorates. In addition to the exams, an awareness campaign was launched about personal hygiene and ophthalmic health. The children also received a backpack with a hygiene kit, coloring books and colored pencils.

This initiative was launched in collaboration with the Gozour Foundation for Development in 2012. Up till now, CIB Foundation has sponsored a total of 441 convoys, benefiting around 301 thousand students in more than 20 governorates. The remaining amount of the project's total value of EGP 8.63 million Egyptian pounds was disbursed in 2020.



23 OUR KIDS OUR FUTURE

The Board approved the allocation of EGP 4.1 million in April 2019 to fund a project in partnership with the Ibrahim A. Badran Foundation, which deployed 48 medical convoys in underserved regions in the Fayoum Governorate. The convoys offered medical services from a team of qualified doctors in various disciplines who will extend medical services to 30,000 children each year. The last two payments were disbursed, with a total of EGP 2.04 million in 2020.

24 STRONG TEETH... BETTER HEALTH

Pediatric Dentistry Clinic

The Foundation allocated EGP 7.5 million in 2018 to fund the purchase of equipment and supplies for the Pediatric Dentistry Clinic in El Kasr El Aini. In addition, the fund allows for the establishment of another clinic in Sheikh Zayed to enhance the services available to children, including those with special needs. The clinic treats more than 95 thousand children each year and is one of the country's few providers of dental services for children with special needs. The remainder of the project's fund amounted EGP 2,58 million has been disbursed during 2020.

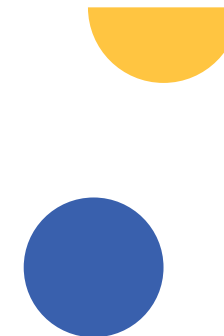
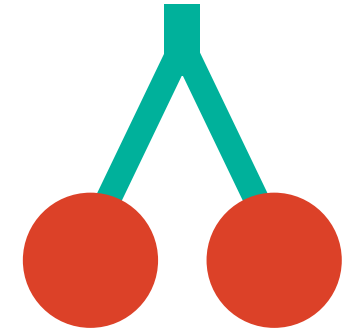
Maxillofacial Unit

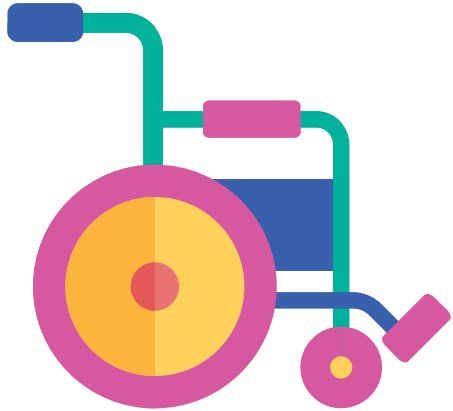
CIB Foundation increased the allocation from EGP 45 thousands to EGP 90 thousands to support the operating expenses of the maxillofacial unit due hikes in the prices of the materials and consumables. Furthermore, CIB Foundation allocated EGP 90,000 to retrofit the malfunctioning sterilization device in the unit. CIB Foundation paid the full amount to the supplier after delivery in 2020.

25 KIDS ON WHEELS

In line with the Foundation's commitment to supporting children with special needs. In April 2019, the Board allocated EGP 4 million to provide 100 children with wheelchairs in cooperation with the Al-Hassan Foundation for Differently Abled Inclusion. These wheelchairs, designed for permanent users, are tailor-made in Germany based on each child's needs. Each wheelchair can serve the child for five years, after which the Foundation may redistribute to other children or make use of the chairs as spare parts. Up till now, three out of four installments amounted EGP 3 million were disbursed to fund the cost of 75 wheelchairs. So that the amount spent in 2020 from the total project's amount is EGP 2 million.

26 WE CAN LIVE TOGETHER

In collaboration with the True Light Society Association, which seeks to integrate children with visual disabilities into society, the Foundation allocated EGP 1.23 million to fund the project. The project's integration aims to culturally and athletically assist visually impaired children in their general life needs and to incorporate visually impaired children into the public schooling system. Equipment provided by the Foundation include Braille typewriters and books, visual assistants, school supplies and others. Training programs are also made available for the children and their parents. This project will benefit 470 children with visual impairments. A total of EGP 960 thousands were disbursed in 2020.



27 HEALTHY CHILDREN

In 2019, the Board allocated EGP 3.38 million to launch two mobile clinics providing comprehensive medical services including pediatrics, ophthalmology and internal medicine to children in remote areas of Upper Egypt in collaboration with Raie Misr Foundation. The clinics will provide the children with checkups as well as medical referrals for specialized cases and medication. The clinics are expected to examine more than 96 thousand children each year. The first and second instalments were disbursed in 2020, with a total amount of 2.25 million EGP.

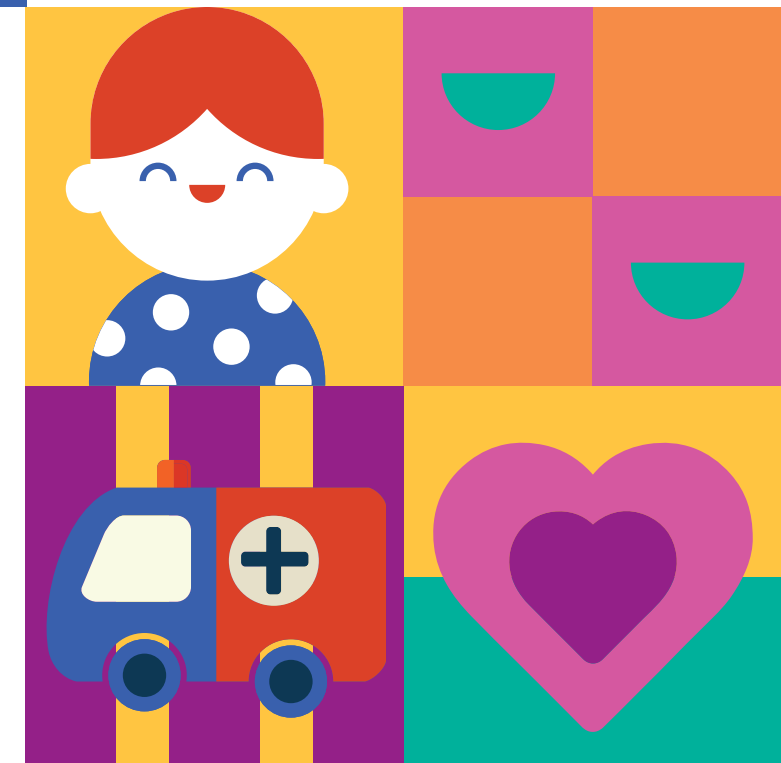
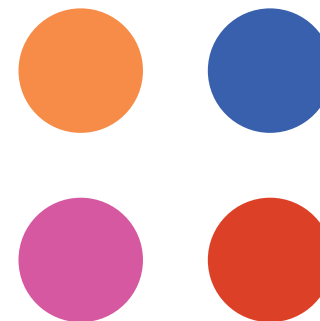
28 OUR CHILDREN'S HEALTH IS PRICELESS

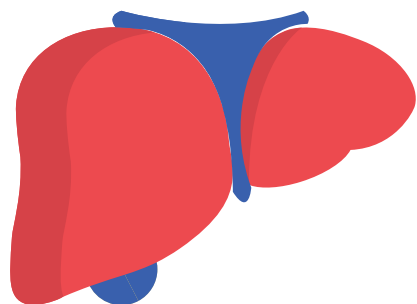
In 2019, The Board allocated EGP 14.45 million to establish a pediatric surgery unit at the South Valley University Hospital, which serves many governorates in Upper Egypt and the Red Sea. The unit will be equipped with state-of-the-art facilities, including a surgical theatre, a pediatric ward (eight beds), an ICU (two beds), and a diagnostic unit. The hospital, one of few in the region, will work to minimize the risk of traveling for critically ill patients and to increase the capacity of the Emergency and Accidents Department to operate on 600 children instead of 150 each year.

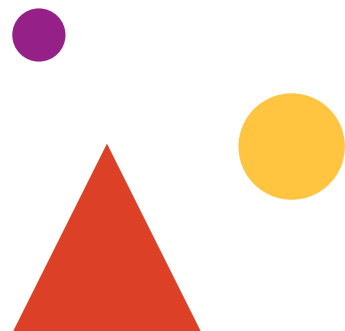
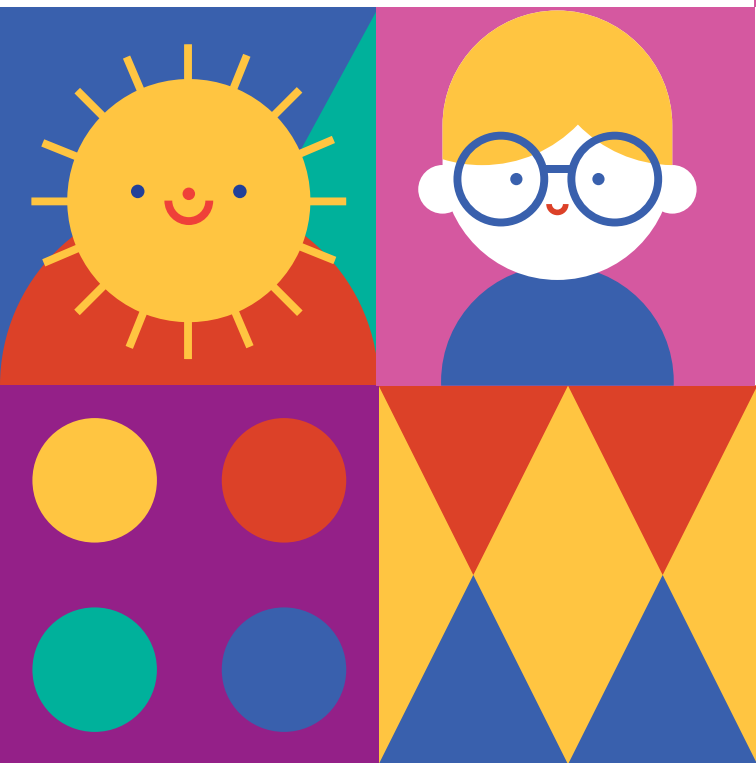

29 KIDNEY CARE AND CURE

In April 2019, The Board allocated EGP 16 million to expand and outfit Sohag University Hospital's pediatric dialysis unit. As the largest unit serving children with kidney diseases in Upper Egypt, there was a pressing need for the hospital to expand. The new dialysis unit features an ICU, a plasma separation room, 16 new dialysis machines, and a central delivery system that will lower infection rates. It is expected to serve approximately 5 thousand children each year.



30 A VISION TO THE FUTURE

In April 2019, The Board approved a budget of EGP 4.63 million to outfit the pediatric ophthalmic clinic at Alexandria University Hospital, considered to be a center of excellence that serves underprivileged families in the Alexandria and Delta regions. This initiative is expected to benefit 8.75 thousand children each year. An amount of EGP 4.47 million was disbursed from the total value of the project in 2020

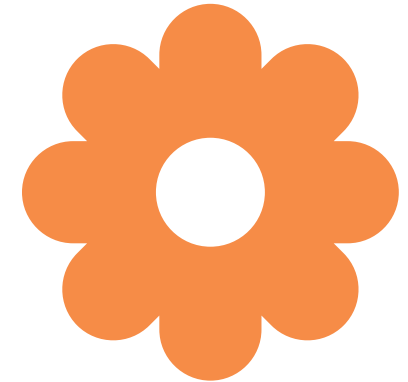
31 SUPERSTARS ARE BORN FROM SCARS

In 2019, CIB Foundation allocated EGP 2 million to fund its second collaboration with Ahl Masr Foundation to cover the costs of surgeries for more than 282 pediatric burn patients at a number of hospitals, including El Kasr El Eini, Ain Shams Specialized Hospital, El Demerdash Hospital and others. This collaboration comes in response to a severe lack of medical care available for burn victims across Egypt, with children under 18 years old making up approximately one-quarter of the total number of victims. An amount of EGP1.72 million was disbursed in 202

32 HEALING HANDS

The Foundation allocated EGP 11.6 million to equip Cairo University Hospitals with a state-of-the-art CT Scanner (128-slices) to detect congenital defects and tumors in the nervous, motor, digestive, urinary and reproductive systems along with examinations of heart arteries. The device is expected to provide scans for 6 thousand children each year. Till date, a total of EGP 3.9 million have been disbursed.

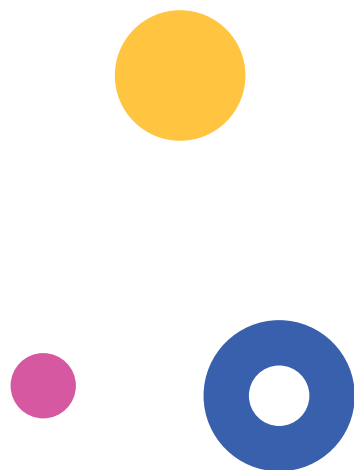

33 A BRIDGE OF KNOWLEDGE

The Foundation will fund a five-year education and training program for 150 staff members of the Ain Shams clinical team (including doctors, nurses, and technicians) in partnership with Great Ormond Street Hospital for Children (GOSH) in London. This initiative follows the upgrade of the hospital's facilities and equipment in line with international standards.


Following the program, Ain Shams University Children's Hospital is expected to double its capacity and serve an additional 67 thousand children each year along with enhancing its overall level of care.

GOSH is an international center of excellence in pediatric care, globally recognized as one of the few world-class hospitals for children suffering from rare, complex or multiple conditions. The emphasis on education and training is key to the delivery of improved patient outcomes. GOSH train more pediatric specialist doctors than any other center in Europe and have Europe's largest pediatric nurse education program, and will work with Ain Shams University Children's Hospital to deliver bespoke education and training with specific focus on pediatric/neonatal intensive care and hematology/oncology.





VOLUNTEERING EVENTS



In February 2020, the Foundation held an event for CIB staff and families to participate in the packing of more than 11.55 thousand school bags that include health and hygiene kits, coloring books, and colors for beneficiaries of the 6/6 Eye Exam Convoys.
