Settling treasury bills / bonds in the secondary market	EGP 150 for each transaction
Unsettling government bonds and treasury bills	One and half in hundred thousands of the transaction value
Settling repurchase agreements (REPO) of government bonds	0.1% (Max. EGP 10,000 for each transaction)
Issuing a special stamped tax report with government bonds and treasury bills	EGP 350
