



CAR LICENSE RENEWAL THROUGH SMART WALLET



A BANK TO TRUST



“You can now renew your car license (including paying your taxes, obligatory insurance, and traffic fines) not only that, you will also receive the new license at your convenient address”

Below is the Vehicle License Renewal process through Smart Wallet “Fawry Services”: This applies for all ***Cairo and Giza Traffic units only.***

The process to renew your license via Smart Wallet “Fawry Services” is as follows:

1. Pay the Traffic Administration (**Traffic Taxes and Fees**)
2. Purchase a compulsory insurance policy (you can choose between 3 companies; **Allianz, Arabic Misr Insurance Group, or Royal**).
3. Pay the Traffic Prosecution (**Traffic Fines**)
4. Request to receive license at Home*.

***Note 1:** This is only applicable for vehicles that do not have any procedures that need to be completed at the traffic unit (for example car inspection, provide formal documents *حظر خطاب البيع من البنك*, etc..), in this case, the customer will have to visit the traffic unit after 4 working days from the payment to complete the procedures and receive the license which will already be printed and ready for the customer.

***Note 2:** In case there are no missing requirements, the transaction will be successful, and a Fawry call center agent will call you the next day to take your address details. You will then receive the license within 7 working days from the transaction.



Traffic Car License Renewal

For all transactions, you will be requested to enter the following:

- Car owner national ID
- Car plate numeric section
- The number of years you want to renew and the mobile number, in case of “Compulsory Insurance” and “Request to receive license at Home”



Traffic Car License Renewal

The service has the following conditions:

- The car must be private (ملاكى)
- The car must be less than 2030 CC
- License delivery is not working in case car inspection or ban
- Did not pass one month after the license expiration date (not after the probation month)
- The total number of years of renewal should not exceed 3 years (i.e if the license still has 6 months to expire, you cannot add 3 years to make the new license expire after 3.5 years). The only case you may renew for 3 years is when the license has expired and you are still in the one-month probation period.
- The inspection year should be the same year or less than of the date the renewal transaction was made on Fawry, or the number of years should not exceed the inspection year. For example, if the inspection year is 2014, you can renew for whatever number of years you want, taking into consideration you will inspect your car when you go to the traffic unit to receive the license. If the inspection year is 2016 and you want to renew via Fawry, you cannot renew for 3 years since the new expiration date will be in 2018 and you cannot inspect now since it is not 2016.

The service has the following conditions:

- The car must be private (ملاكى)

- License delivery is not working in case car inspection or ban

Traffic Car License Renewal

In case of not being able to pay your traffic fines through Smart Wallet, please note the following:

- Please go to your nearest traffic unit and complete your personal information by providing the following:
- Original License
- Original National ID
- Proof of Statement for (صرف اللوحات من وحدة الترخيص المختصة)

NB: Please note that the maximum amount of daily transaction through Smart Wallet is EGP 6,000.
